

IMPORT DUTY EXEMPTION CERTIFICATE (IDEC) IS A FISCAL INCENTIVE BY THE FEDERAL GOVERNMENT UNDER THE MINISTRY OF FINANCE TO BOOST SECTORS OF THE ECONOMY BY EXEMPTING CRITICAL PLAYERS FROM PAYING IMPORT DUTY AND ALL OTHER STATUTORY CUSTOMS CHARGES RESPECTIVELY.






